represented by Dr. Chandrakant Mahakalkar, C.M.S. herein named as Party One.

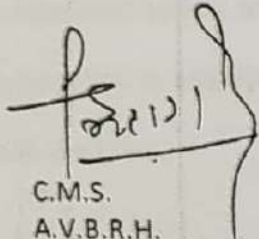

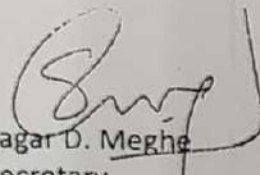
