AND

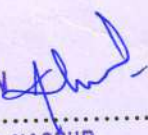
Nagar Yuwak Shikshan Sanstha having its Registered Office at Atrey Layout, Nagpur

two.

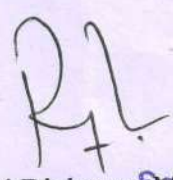


The parties hitherto agree as follows :-
