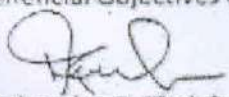

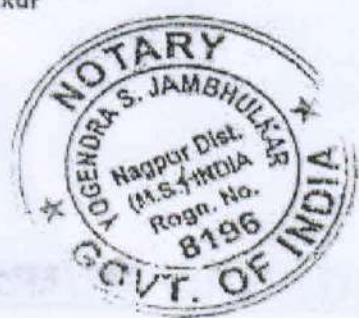


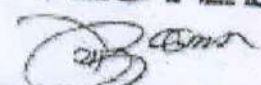
1. Party One declares that, Nelson Mother & Child Care Hospital, Dhantoli, Nagpur is a 64 bedded hospital.
